Winners Announced in 4th Annual Regional Who Powers You? Contest

Traverse Electric is excited to announce the three winners of the fourth annual Who Powers You? contest, who were chosen from among its 20 finalists. Each year, the contest, held in partnership among Touchstone Energy[®] Cooperatives throughout the region, spotlights outstanding individuals and organizations across eastern South Dakota and western Minnesota who are making a difference in their communities while recognizing them for their remarkable efforts in empowering and inspiring others.

"The Who Powers You? contest highlights the commitment of our co-op to the communities and member-owners that we serve. A total of twenty finalists were featured weekly on KELOLAND Living from March through mid-May. Three contest winners were announced on May 22, 2025. Winners were chosen by a panel of judges.

Area IV Senior Nutrition, headquartered in Northern Electric Cooperative's service territory, has been awarded the first-place grand prize in the contest.

The organization serves individuals across a 16-county region in central and northeastern South Dakota. For 51 years, they have worked to support the health and wellness of older adults by providing nutritious meals and meaningful social connections. Their efforts not only help seniors maintain physical health but also foster emotional well-being through companionship.

2025 Mid-Year Update

Happy July, Traverse Electric Members! That feels weird to say all ready... This month's 'Watt Matters' is all about what has happened at Traverse Electric the first half of 2025 and what's going on the rest of the year.

OPERATIONS

Our crews have been extremely busy with our work plan projects, overhead to underground reliability projects, and new services. A couple areas where larger work plan projects are being completed are:

- 469th Ave south of Victor. Our crews are completing 3 miles of overhead 3 phase and 1 mile of 1 phase to underground from 110th St to 114th St.
- 110th St south of Claire City. Our crews are completing 2 miles of 3 phase overhead to underground.
- 640th St south of Wheaton. Our crews are retiring a mile of inaccessible 3 phase and we rerouted the 3phase along HWY 27.
- HWY 6 east of Dumont. Our crews are completing a 5 mile stretch of 3ph from overhead to underground from CR-77 to 630th Ave.

Financials

Traverse Electric is off to a good start financially to the year. Through month end of May, we have an operating margin of \$412,153.21 and total margin of \$794,404.28. A couple things to remember when it comes to our current margins:

- 1. Our tree trimming contractor has not started. They plan on starting in July.
- 2. The sale proceeds of our old building went into our total margins
- 3. The rate increase. We were budgeting for larger margins in 2025 to offset the rate increase from our power suppliers in 2026. As we near the end of the year, we will assess what we will carry over as revenue deferral.

Personnel

Long-time journeyman linemen, Lon TeKrony, accepted a position as an instructor at Mitchell Tech in Mitchell, SD. Lon's last day of work was June 20th. We wish Lon & Starla the best of luck on their new endeavor. Isaac Callens, journeyman linemen, left at the beginning of May to accept a position with Marshall Municipal Utilities. Joining our team in June were Jordan Pearson, 3rd year apprentice, and Isaac Hoverson, journeyman lineman.

Software

We go live with NISC for our service, payments, billing, staking, and mapping on July 14th. We will have some down time for payments and entering information into the software a week prior to conversion, so that they can convert all information over correctly. Our staff has worked very hard during this conversion!!
