2024 in Review Traverse Electric Cooperative Annual Report from the President and General Manager

It is our pleasure to welcome everyone to Traverse Electric's 85th annual meeting on behalf of the board of directors and your co-op employees. This year's annual meeting will be held in-person at Wheaton High School on March 20th at 6:30 pm. This year will be a business meeting only, where registered members, who stay for the business meeting, will receive a \$40 food voucher that can be used at many area participating businesses that are printed on the back of the voucher anytime until the end of 2025. Although we encourage everyone to use their \$40 vouchers at our area restaurants, vouchers may also be turned into Traverse Electric's office for a \$20 electric bill credit.

In 2024, TEC received high marks in several categories. Your Cooperative ended the year with \$13,469,399.93 in operating revenue and 130,505,113 in kWh sales. In addition, we ended the year with an operating margin of \$149,158.10 and total margins of \$1,089,144.88. We returned \$468,822 to estates and general retirement capital credits to those who received electricity in 2008 due to the Cooperative's sound and stable financial condition. That adds up to more than \$11.7 million returned over the years - quantifiable proof that you are an owner of a successful, effective organization.

The Cooperative's growth continued in 2024, with line crews installing and upgrading services for new homes, grain dryers, and tile pumps. In 2024, a total of 43 new services were installed and 90 services were retired. Traverse was able to start on our 4-year work plan projects Jeremy Huhnstock General Manager



with installing two 3-phase projects; a mile long project just west of Wheaton along Highway 27 and a 5-mile project east of Dumont along Highway 6. Both of these projects will be finished in the spring. We continued to work on our maintenance programs, including pole testing, OCR maintenance, overhead line inspection, underground inspection, and right-of-way inspection.

While we are proud that planning and hard work has paid off, we still remind ourselves that dependable service and customer satisfaction are as – or maybe more critical – than bottom-line numbers. As we work our way into 2025, we will keep those thoughts in mind and continue to deliver more than just electricity to our members.

In closing, our sincere thanks to our members for your continued patronage this past year. We appreciate your business and the opportunity to serve as your board president and general manager. We also want to express our thanks and appreciation to our employees. Their constant service, commitment to the membership, and support for our mission have enabled the Cooperative to complete another successful year in 2024. Their collective expertise and steadfast effort at what they do help us move forward confidently down this new road we are traveling as we search and discover new and better ways to serve our members. Cheers to a happy & healthy 2025!!



Mailing in Secretary, Glynn's absence.

President Diekmann called for the reading of the minutes of the last annual meeting and requested to dispense with the reading of the minutes. A motion was made and seconded to dispense with the reading of the March 23, 2023 minutes as printed in the March newsletter and to approve them. Motion carried.

President Diekmann recognized the Board of Directors and employees for their hard work and dedication.

President Diekmann introduced Chris Studer as a special guest from East River Electric. Studer spoke about East River and future growth.

General Manager, Jeremy Huhnstock presented the 2023 Operating and Financial Reports. Topics reviewed included:

- Our March 31, 2023 and year end December 31, 2023 financials received a clean audit report by our independent auditing firm, CliftonLarsonAllen.
- 2023 operating revenue and kwh sales were reviewed.
- Capital credits were retired in December 2023 totaling \$600,000 from 2007 & 2008 to members and estates.
- Reported that a class cost of service study was completed in 2023 as a tool to align costs, which resulted in a rate adjustment that went into effect on January 1, 2024
- Reviewed new services connected and projects completed in 2023. Most of the new services were for tile pumps.
- Reported on maintenance programs such as pole testing, tree trimming, and OCRs that are on a rotation schedule.
- Supply chain and higher material costs were issues again in 2023.

General Manager Huhnstock asked the membership if they had any questions on the reports. After no further questions, a

motion was made and seconded to accept the Treasurer and Operations Reports as given. Motion carried.

President Diekmann gave the Presidents Report:

- Encouraged members to read the report as printed in the newsletter.
- Present and past board members in attendance were recognized.
- We moved into the new building in July 2023 and held an open house in October that was well attended.
- Reported on Minnesota and South Dakota legislation that affects things such as permitting for transmission lines in MN and landowner rights in SD.
- Scholarship winners were announced.

President Diekmann opened the polls for the election of directors. The candidates running for director from Districts 2, 5, and 8 were running unopposed. Any member from these districts can be a candidate for director by obtaining 10 signatures from members in their district. Diekmann announced the following candidates who were nominated at the district meetings or turned in signed petitions with at least 10 member signatures:

A motion was made and seconded from the floor to cast a unanimous ballot for each of the candidates. Motions carried. Emmy Anderson, our 2023 Washington DC Youth Tour delegate gave a brief report on her trip.

President Diekmann asked for any old business, and there being none, he proceeded to ask for any new business. There being none, it was moved and carried that the meeting be adjourned. Final adjournment.
